

## Main Objectives & Activities

- <u>Main Objective:</u> Reducing the marine littering from tourism sector by 60% in the Mediterranean region
- <u>The expected outcome/Impact</u>: Complete solution/model to establish opportunities for new industry, business and jobs creation based on waste from coastal tourism sector.
- The project is applied in 3 south Mediterranean countries, Morocco, Tunisia, and Egypt.
- The project activities will be applied by local partner (AASTMT in Egypt) with local stackholders, including the Ministries of Enviroment, Tourism, local development in addition to Hotels, Associations, NGOs, local comunities.
- AASTMT as the local partner in Egypt is considered the focal point of the project to estabilsh a communication channel to involve all the local stackholders in the project activities satisfying the project objectivies and goals.


# WP I: Coordination, networks, pilot areas and background data analysis


Evaluation and identification of pilot areas

Alexandria is selected to be the pilot area (the most populated city on the Mediterranean (about 6 Millions) with high rate of local and international tourism activities.

## WP III: Development of EPR concept for the benefit of tourism sector at national level

- Conduction of workshops for all the stakeholders and cooperation partners to present the Extended Producer Responsibility (EPR) concept and adjustment needed including for pilot design
- Three workshops have been organized with WMRA to discuss the EPR concept and the challenges regarding the EPR implementation.
- TouMaLi team developed a draft PRO business plan for WMRA to be applied for the single use plastic bags which is the first step in EPR implementation.
- Two EPR models are proposed by TouMaLi team to be applied in case of implementation of the EPR concept or if it is not active.

## WP IV: Monitoring, quantification and tools



Three beach monitoring campaign are implemented March 2022, June 2023, Sep 2023

The beach campaigns cover 6 beaches in Alexandria and 2 in Maras Matrooh.

During the high season, (June 2023) The manual cleaning activities are done continuously during the day with 2 main cleaning actions every 12 hours at the morning time and the sunset time.

The campaigns are conducted early in the morning before the morning cleaning activity.

## **Conducted Beach monitoring Campaigns**



The primary results show that:

As expected for high season with continuous cleaning activities, all the beaches are low polluted except one public beach which can be classified as a moderate polluted beach.

The sand rack method is used in all the low polluted beaches since there is no waste with large size.

Cigarette butts are the most commonly waste found in the sand rack method analysis.

In general, the primary analysis for the high season shows a values less than 30% - 20 % of the values recorded during the off season (March period – 6 months without cleaning).

#### WP V: Implementation of local waste reduction solution **TouMaLi Sorting Center-Alexandria**


As agreed before the centre will be constructed using shipping containers as required by Nahdet Misr Co.

Different proposed layouts are suggested to fit the required spaces for the equipments and different working, operation and storage areas.

The layouts has been sent to Nahdet Misr civil engineering team to review and we received the comments according to their restrictions and conditions.

We developed the layout satisfying their conditions and finally we achieve an accepted version from

Nahdet-Misr team.






















#### For the Beach cleaning machines:

The technical offers are evaluated and the price negotiations with the company with the accepted technical offer are done

We get a 7% discount with 18 month guarantee and a free spare parts kit for one-year maintenance

#### For the Bins

The technical offers are evaluated from suppliers.

A good technical and financial offer from German supplier to ship a full container with 120 L and 240 L bins to Alexandria.

We get many offers from different suppliers with a help from Nahdet Misr Co. (our project partner) for different types of trucks.

The primary accepted offer for 2- open Trucks with 5 Tons capacity. We are now negotiating about some technical modifications regarding adding the bin lifter.

We still waiting the technical and financial offer.


