- **Strengthening Institutional Frameworks:** Nations should enhance their governance structures to support effective waste management policies.
- Innovating Waste Management Practices: Transition the waste sector towards a
 model that prioritizes environmental protection while creating economic value through
 resource optimization.
- **Sustainable Tourism Operations:** The tourism sector must adopt circular economy principles, including reduce, reuse, and redesign strategies.
- Educational Initiatives: Reinforce training in the HoReCa sector, promoting sustainable practices and collaborations to tackle single-use plastics.
- **Knowledge Sharing:** Facilitate the exchange of best practices through toolkits and digital platforms to foster effective waste management across partner countries.
- **Monitoring Systems:** Establish measurable goals and a robust framework to track progress in reducing marine litter and plastics.





• Engaging the Informal Sector: Develop strategic approaches to integrate informal waste handlers into formal systems, recognizing their contributions to sustainability.

We commend the successful establishment of the "Arab Renaissance Company for Environmental Solutions and Innovation" in Egypt, exemplifying effective public-private collaboration within the scope of the TouMaLi project.
